PROGRAM DETAILS

By registering for the Northwoods Fall Getaway Program:

- Every time you purchase a product from one of our participating suppliers, you will earn credits toward a 3-night getaway at Coon's Franklin Lodge on Trout Lake in Arbor Vitae, WI September 12-15, 2021.
- You will receive a list of participating suppliers as they become available.
- All purchases from participating suppliers, beginning February 1, 2021 through July 31, 2021, will earn credits toward the getaway.
- Customers must sign up no later than June 30, 2021. Credits earned will be retroactive to February 1, 2021.
- Registration is limited to the first fifty people, with no more than 2 people per business.

PROGRAM QUALIFICATIONS

To earn points on qualified purchases:

- Participating Company accounts must remain current throughout the program.
- Your Northwoods Fall Getaway will be billed in July and must be paid Net30. (Please see Pricing & Billing.)
- Credits on specially priced products and/or large commercial jobs will be determined on a case by case basis. (Ask your Rundle-Spence sales representative.)
- All invoices must be paid in full before the getaway will be awarded.

CREDIT STATEMENTS

- Credit Statements will be issued on a monthly basis, beginning May 31, 2021.

NORTHWOOD FALL GETAWAY PRICING AND BILLING

- You will be billed for your getaway in full on July 1, 2021.
- Invoices must be paid Net30.
- All credits earned throughout the program, February 1, 2021 through July 31, 2021, will be applied against your getaway on August 1, 2021, and credit issued.

ACTIVITIES

- Activities during the getaway will be determined and offered on a first come, first served basis.

- Sign-up forms will be issued to participants as the getaway dates approach.
